(Revenue \$ ) Individualized Student Support - Through the School Success Program, the Organization places staff at selected middle and high schools to work with students who are most vulnerable for dropping out: young people affected by gangs, violence, family disruption, and poverty. Students receive support to raise academic achievement, reduce truancy, and address barriers to learning. Personalized support to students and their families helps them to overcome social and emotional obstacles that stand in the way of students fully engaging in school.

4b (Code: ) (Expenses \$ 27,824. including grants of \$ ) (Revenue \$ 2,240.) Academic Enrichment - Elementary and middle school students are paired with volunteer tutors during school and after-school to address learning gaps in reading and math. The Organization also collaborates with community partners to provide a variety of services and activities that enhance students' and families' experiences with school. Areas of focus include goal-setting, health and fitness, financial literacy, field trips, arts and culture, and educational workshops for parents.

4c (Code: ) (Expenses \$ 30,114. including grants of \$ ) (Revenue \$ ) Prevention Programs and Other Services - Throughout the year the Organization coordinates and brokers services for several Seattle schools. The Organization provides thousands of students with backpacks and school supplies annually. Gently used books, holiday food baskets, connections to clothing, and personal hygiene items are given to students and families who can least afford these items. The Organization also connects other community services and programs to schools, based on school needs.
